**Background** Following the agreed Roadmap for the development of national strategies to counter the proliferation of weapons of mass destruction, the **C-WMD Network** in RACVIAC is organising the seventh meeting of the national working/drafting groups in April 2017.

The **C-WMD Network** welcomes the continuous support from U.S European Command (USEUCOM) in providing experts from the U.S. Defence Threat Reduction Agency (DTRA), the International Counterproliferation Program (ICP), the European Union, Armenia, Austria, Bulgaria, and Croatia, upon availability. The **C-WMD Network** also welcomes the support of the Proliferation Security Initiative (PSI) in the planning and execution of this activity.

**Purpose and Objectives** The purpose of this event is to continue facilitating the development of National C-WMD Strategies and Action Plans as the key focus of the project. The main objectives for this activity are:

- To peer review progress in the development of C-WMD national strategies;
- To present the challenge dual-use goods and emerging technologies pose to counterproliferation regimes;
- To discuss emerging technology and intangible technology transfers (dual-use technology versus “traditional” proliferation);
- To discuss the proliferation aspects of terrorism;
- To exercise concepts through a PSI Table-Top Exercise.

**Participation** The aim of this activity is to bring together 2-3 members of the core working/drafting group and 2-3 experts working on licensing, customs, legal issues, or intelligence.

Detailed terms of participation and financial arrangements will be specified in the corresponding Invitation Letter and Administrative Information.

**Methodology** The event is designed as an expert forum and it will be conducted through open discussion, case-studies, presentations from experts, and a PSI table-top exercise divided into four phases.
